Notice is hereby given that the Board of Directors of Windfern Forest Utility District will hold a regular meeting, open to the public, on **TUESDAY, JULY 16, 2013**, at 4:00 p.m. at the Windfern Forest Utility District Administration Building, 14410 Mauna Loa Drive, Houston, Texas, 77040, inside the boundaries of the District, to consider and take action upon the following matters:

1. Appearances before Board
15 minutes – A speaker whose subject matter relates to an identifiable item of business on this agenda will be requested by the President or other presiding Board member to stand and address the Board for no more than 3 minutes; however, no more than 15 minutes will be allowed for each subject matter.
2. Approve minutes of previous meetings.
3. Security report:

4. Engage auditor to conduct annual audit for fiscal years ending September 30, 2013 and 2014.
5. Bookkeeper's report:
 - a. fund balances and disbursements;
 - b. payment of bills;

6. Tax Assessor/Collector's Report:

 - b. account balances;
 - c. disbursements; and
 - d. tax transfers.
7. Delinquent Tax Attorney's report:
 - a. collection activity;
 - b. filing of lawsuits;
 - c. cut-offs due to non-payment of taxes;
 - d. installment agreements;
 - e. write-offs/uncollectibles; and
 - f. demand letters.
8. Operator's report:
 - a. connection activity;
 - b. regulatory matters (permitting, subsidence);
 - c. water production and accountability;
 - d. billing and collections;
 - e. delinquent accounts;
 - f. operations, maintenance, and repairs of District facilities; and
 - g. drought conditions.

9. Hearing on termination of service to delinquent water and sewer accounts and authorize appropriate action.
10. Engineer's report:
 - a. status of water transmission line project and project timeline and execute contract documents;
 - b. response from TCEQ for exception to well capacity requirement and elevated storage tank waiver application; and
 - c. design and construction of Water Well No. 3 at Water Plant No. 1.
11. Attorney's report:
 - a. Participation in the Water Wise Program with The Subsidence District; and
 - b. status of application for funds for a hike and bike trail.
